

# CONTEST RULES

## ***1,000,000 Milliplein points to be won***

### **1. CONTEST ORGANIZER**

The *1,000,000 Milliplein points to be won* contest is being held and organized by La Capitale General Insurance ("La Capitale" or the "Contest Organizer").

### **2. CONTEST PERIOD**

The contest will be held in Quebec from 12:00 a.m. ET on February 15 to 11:59 p.m. ET on May 15, 2019 (the "Contest Period").

### **3. ELIGIBILITY CONDITIONS**

To enter this contest, participants must:

- Be a resident of the province of Quebec
- Age 18 or over on or before May 15, 2019.

### **4. HOW TO ENTER**

Participation in this contest is free, with no purchase necessary.

To enter the contest, individuals must satisfy the eligibility conditions and the other conditions set out in these contest rules.

Subject to the limitations contained herein, there are two (2) ways to enter during the Contest Period:

#### **A. At the time of a telephone or online quote**

By indicating the Milliplein contest when requesting a telephone quote from La Capitale or one of its authorized representatives, or when obtaining an online quote at [lacapitale.com/millipleincontest](http://lacapitale.com/millipleincontest) for a home, automobile or leisure vehicle insurance product that is eligible under Section 7.3 of these rules.

By indicating the Milliplein contest when requesting a telephone quote from La Capitale or one of its authorized representatives, or when obtaining an online quote at [lacapitale.com/millipleincontest](http://lacapitale.com/millipleincontest).

The quotes must be regarding a home, automobile or leisure vehicle insurance product that is eligible under Section 7.3 of these rules.

Limit: One (1) entry per person.

#### **B. By being insured with La Capitale General Insurance Inc.**

Those who already hold a home, automobile or leisure vehicle insurance contract that is eligible under Section 7.3 of these rules and in effect at the end of the Contest Period, and who have provided their Milliplein card number are automatically entered in the contest.

Individuals may submit their Milliplein member number by contacting a La Capitale agent by telephone or by filling out the “Benefits with our partners” section under the “Home, auto and leisure vehicle insurance” section at [lacapitale.com/ClientCentre](http://lacapitale.com/ClientCentre).

Limit: One (1) entry per person.

## 5. PRIZE DETAILS

The retail value of the Milliplein rewards is 1,000 Milliplein points equalling a \$1 rebate. The winner can exchange his or her Milliplein points for [gas](#), items from the convenience store, car washes or mechanical work, in participating EKO gas stations.

The winner may also redeem the Milliplein points with an authorized partner in accordance with applicable program conditions.

If the winner is not already a Milliplein member, Milliplein will register the winner for the program and will add the Milliplein points to that person's account within four (4) weeks of registration.

## 6. SPECIFIC PRIZE CONDITIONS

Prizes cannot be refunded, transferred, redeemed for cash or assigned.

## 7. DRAW

**7.3** Insurance products eligible for the draw are the following: Personal automobile insurance, home insurance for tenants, home insurance for condominium owners, home insurance for homeowners, watercraft insurance, trailer insurance, motorhome insurance, snowmobile insurance, ATV insurance and motorcycle insurance.

**7.4** La Capitale reserves the right to disqualify participants or entries that are not in compliance with contest rules.

## 8. ENTRY RESTRICTIONS AND EXCLUSIONS

**8.1** The number of entries per person is limited, as described in Section 4 of these contest rules.

**8.2** Employees, mandataries, directors and representatives of La Capitale and its affiliated companies, and individuals residing at the same address, may not enter the contest.

**8.3** Also excluded from entering the contest are affiliated agents and agencies, their employees and individuals residing at the same address.

## **9. GENERAL CONDITIONS**

**9.1** To be declared a winner, the entrant selected at random must:

- Be reached by telephone by the Contest Organizer, to discuss prize delivery arrangements within five (5) business days of the draw. To avoid being disqualified, be reached in no more than two (2) attempts and, if a voicemail message is left, return the Contest Organizer's call within five (5) days of the voicemail.
- Confirm that he or she meets the eligibility conditions and other requirements of these contest rules.
- Correctly and without assistance, answer a timed mathematical skill-testing question administered by telephone.

If no participant is declared a winner within thirty (30) days following the original draw, the Contest Organizer will have the right to cancel the prize.

**9.2 Verification** Entry forms are subject to verification by the Contest Organizer. Any entry or entry attempt that is deemed to be fraudulent, illegible, incomplete, received late or otherwise not in compliance with contest rules will be rejected. In such a case, the participant in question will not be entitled to an entry or a prize. The Contest Organizer's decision concerning any aspect of the contest, including but not limited to the eligibility or disqualification of entries or participants, will be final and without appeal, subject to a decision by the *Régie des alcools, des courses et des jeux du Québec* (RACJ) with regard to any matter under its jurisdiction.

**9.3 Disqualification** The Contest Organizer reserves the right to disqualify any person or cancel one or more entries from a person who enters this contest or tries to do so by any means contrary to these contest rules or which would be unfair to the other participants. Such person may be referred to the appropriate judicial authorities. The Contest Organizer's decision regarding this aspect of the contest is final and without appeal.

**9.4 Prize acceptance** The prize must be accepted as described in these contest rules and is not, in any case, transferable in whole or in part to another person, unless otherwise indicated herein.

**9.5 Limitation of liability – Use of the prize** The prize winner releases the Contest Organizer, its advertising and promotional agencies and their employees, agents and

representatives from any damage, inconvenience or loss resulting from his or her acceptance or use of the prize. Each participant selected acknowledges that, as of his or her being informed of the prize delivery arrangements, the fulfilment of the obligations related to the prize becomes the entire and exclusive responsibility of the various service and product providers.

**9.6 Limitation of liability – Contest operation** The Contest Organizer, its advertising and promotional agencies and their employees, agents and representatives are not liable for any faulty computer components, software or line of communication, or for the loss or absence of network communication capability, or for any faulty, incomplete, incomprehensible or erased computer or network transmissions that make it difficult or impossible to enter the contest.

**9.7 Limitation of liability – Registration** The Contest Organizer, its advertising and promotional agencies and their employees, agents and representatives are not liable for any damage or loss that may be caused, directly or indirectly, in whole or in part, by the downloading of any web pages or software or by the transmission of any information concerning contest participation.

**9.9 Notice to entrants – Information disclosure outside of Quebec** La Capitale and its affiliated companies may be doing business with one or more service provider(s) based outside of Quebec. It is therefore possible that some of your personal information held by La Capitale may be stored outside of Quebec and governed by the laws of foreign countries or states. By completing such forms, participants tacitly accept such a situation.

**9.10 Authorization** The prize winner authorizes the Contest Organizer and its representatives to, if required, use his or her name, photograph, image, voice, contact information, place of residence or any statement relating to the prize for advertising purposes, without any compensation.
